



- Library licensed etextbooks: 13% included in RCL and 1% have Outstanding Academic Text designation
- All assigned texts at ISU: 13% included in RCL, with 0.4% designated as Outstanding Academic Texts
- Demand Driven Acquisition: 7% included in RCL and 0.6% designated as Outstanding Academic Texts.

Why Do a Diversity Audit?

social and professional responsibility

"Books and other library resources should be provided for the interest, information, and enlightenment of all people of the community the library serves. Materials should not be excluded because of the origin, background, or views of those contributing to their creation." (Article I, <u>ALA Bill of Rights</u>)

"A diverse collection should contain content by and about a wide array of people and cultures to authentically reflect a variety of ideas, information, stories, and experiences." (ALA BOR Interpretation)

- collection management is non-neutral
- we have to approach it with intentionality
- none of us do it as well as we might think/hope
- structural systems of exclusion beyond our control
- publishing industry is not equitable

Bowker Book Analysis System

- Collection Analysis tool
- Quantitative AND Qualitative
- Retrospective AND forward-looking
- Compares holdings data against Resources for College Libraries (RCL)
 core titles
- RCL subjects
- LC classification ranges

Advantages & Limitations

Advantages:

- Automated
- Quick turnaround
- Provides a benchmark
- Title lists for collection development

Limitations:

- Requires a subscription
- Matching errors
- Reports by call ranges miss interdisciplinarity
- Broad subject categories
- Some core titles may be out of UWF collection scope

The **University of Wisconsin-Stevens Point** has used BBAS together with RCL for continuous collection assessment for over ten years. Recently, UWSP Libraries applied the tool to assist staff through a deselection project aimed at reducing the collection size and relocating to a new building. Changing times for the Albertson Learning Resource Center and "The Library" Working to keep an even-keel leveraging & assessing collections

Library main structure was built in 1970, wing additions and 6th floor added in 1986, lobby remodel in 2002, followed in 2012-forward, a continuous series of space renovations as the Library became part of the University College. In 2019 plans were approved for new building construction, to open 2025-26.

2012 - 2013 UWSP Library Collection Assessment begins using RCL/BBAS

Origins of current UWSP Library Collection Assessment Plan

Objective - retool space for collaborative academic units and services > goal - weed 5% of stacks, establish regular assessment Retention criteria and working guidelines > thresholds - publication date - usage - local niche - last copy - professional judgement Compliance with national bibliographies such as Best College Books/RCL web

"If in BBAS/RCL (Bowker Book Analysis System/Resources for College Libraries), retain."

Setup Collection Assessment LibGuide – post rationale, potential WD lists for campus input, access RCL/BBAS

2020 - 2021 - Prepare for moving collections offsite > collection assessment/weed to lighten moving costs and labor

Revise criteria and workflows – update LibGuide and use Team Files

Objective – weed 15% (we weeded 18%)

Compliance with national bibliographies – if in BBAS/RCL retain.

2023 - 2025 Prepare for return to library in new building (2025-26)

Ease to weed offsite, workflows, save moving costs

Identify outdated editions, worn materials, evaluate remaining series and indexes –

Objective – reach 20%+ weeding level for reduced space/shelving in new building

Compliance with national bibliographies – if in BBAS/RCL retain.

Use RCL/BBAS – identify LC classification/subclass address Core % levels - add Core titles – curricula changes/growth

Other workflows

Gifts – if in good condition, check our holdings for duplicate items, check for # of copies in UW Sys

If in RCL add to collection/check for best copy

Replacements (lost/worn items) check number of copies (local and UW Sys)

If in RCL – replace/repair/order new copy for collection

Importance of Tech Support! - Tools and Staff

Technologies - inventory tools - Shelf Lister (used in past) > Alma Analytics (great improvement) – BBAS – keep current BBAS load updated holdings

Instructions for Reviewing Withdrawal Candidates

Withdrawn Titles/Library Discards

Items proposed for withdrawal will remain shelved in the Library during the designated period for review (normally 30 days, dates are posted with each list).

Purpose of the Project

The University Library is an innovative partner in the learning community and an active participant in promoting the University's goals of teaching, learning, scholarship and community outreach. The Library provides quality academic services and resources that foster intellectual curiosity, promote critical inquiry and encourage awareness of an increasingly diverse and global environment.

In line with the University Library's mission, the Library has started a full collection assessment of our Stacks print holdings. This Collection Assessment Project not only involves weeding, but will provide the opportunity to improve our core collection, address curricula changes and areas of academic program growth, augment unique subject niches, and identify related resource needs.

Retention Criteria

- 1. Consider circulations (charges) and in-house use (browses) to be one and the same. Add these together to formulate the "Rule of 5."
 - a. If an item has 5 or more transactions (charges and browses), retain.
 - b. If less than 5 transactions, if any transactions were during or after the year 2005, retain.
 - c. If less than 5 transactions but the item was added to the collection during the year 2005 or later, retain.
- For duplicate titles, apply the Rule of 5 to each copy. If neither copy passes the Rule of 5 text, apply the numbers aggregately to the title. If it then passes, retain one copy of the item.
- 3. If multiple editions, apply the Rule of 5 to each edition. If older editions pass the Rule of 5, prefer retention; if each older edition fail the Rule of 5, prefer de-selection (Exceptions as in step 7, historically significant titles, prefer retention).
- 4. If in BBAS/RCL (Bowker Book Analysis System/Resources for College Libraries), retain.
- If the item does not meet any of the above criteria, check Universal Borrowing for last copy in UW System. If last copy, refer to UW System Last Copy Policy.
- 6. If the item does not meet the above criteria but is particularly relevant to Central Wisconsin, UWSP or the curriculum, prefer retention.
- 7. Prefer retention of historically significant titles.

These are working guidelines only. Librarians will exercise professional judgment and knowledge of their subject areas when making collection development and weeding decisions. Threshold/parameters may be different for various disciplines and/or library units (i.e., books used in History as compared to Business). Additional parameters of library collection assessment and how its collections are conceptualized will include:

- 1. The depth and breadth of the collections, using Library's CD policy and based on ALA identification of collection levels;
- The importance of compliance with national bibliographies such as RCL web and other;
- The significance of consortia shared resources, and their retention;
- 4. Our responsibilities to the One System, One Library initiative, in the context of all UW System libraries, noting discussions of how many copies of any title are needed to serve the entire system, and "last copy retention" considerations.

All potential items to be withdrawn will be posted in the "lists" tab of this website for review and feedback by campus faculty.

Enhancing our Core Collection

We fully anticipate that this process will identify subject gaps in our current collection. To this end, we have established a Core Collection Fund line to support the acquisition of new core titles, which will address identified needs and enhance the Library's collection.

We welcome faculty requests for core titles selected from Resources for College Libraries — a database that provides a list of core titles in 117 subject areas that are essential for undergraduate study.





- What worked, what didn't, what's next
- Continue weeding/assessment offsite 2023-2024, goal is to prepare for new building –
- Refocus on unused index series, multiple copies, worn materials, outdated editions, LC classifications and subclasses not previously completed
- Additional initiative: use Thrift revenue to support Core title acquisitions in FY24 – forward, using BBAS reports to focus on subject area weaknesses, program growth and curricula changes, reinforce diversity – inclusivity, student retention/success
